Section 3: Hazards Identification

Potential Acute Health Effects: Very hazardous in case of skin contact (irritant), of eye contact (irritant), of ingestion. Hazardous in case of skin contact (permeator), of inhalation (lung irritant). Slightly hazardous in case of skin contact (corrosive). Eye Contact:
